**Conditions Imposed under Section 5(12) of the EIA Ordinance
for Permission to Apply Directly for Environmental Permit**

1. All the mitigation measures described in the Project Profile (No. PP-606/2020) submitted with the Application (No. DIR-276/2020) by the Applicant on 27 July 2020 shall be fully implemented.
2. The Applicant shall employ an Environmental Team (ET) to carry out the EM&A requirements, and an Independent Environmental Checker (IEC) to audit the overall EM&A performance of the Project and the implementation of all the mitigation measures in (1) above or as directed by the Director and submit EM&A reports to the Director during and upon completion of the construction works.
