- 1.1 The Permit Holder and any person constructing or operating the Project shall comply with all conditions set out in this Permit. Any non-compliance by any person may constitute a contravention of the Environmental Impact Assessment Ordinance (EIAO) (Cap. 499) and may become the subject of appropriate action being taken under the EIAO.

This Permit does not of itself constitute any ground of defence against any proceedings instituted under any legislation or imply any approval under any legislation.

The Permit Holder shall ensure that the most updated information about this Permit, including any amended Permit, is displayed at such locations. If the Permit Holder surrenders a part or the whole of this Permit, the notice he sends to the Director shall also be displayed at the same locations as the original



Permit. The suspended, varied or cancelled Permit shall be removed from display at the construction site(s).

1.7 The Permit Holder and any person constructing or operating the Project shall ensure that the Project is designed, constructed and operated in accordance with the information and recommendations described in the Project Profile (Register No.: PP-655/2023); the application documents for environmental permits; other relevant document in the Register; the information and mitigation measures described in this Permit; mitigation measures to be recommended in submissions that shall be deposited with or approved by the Director as a result of permit conditions contained in this Permit, and mitigation measures to be recommended under ongoing surveillance and monitoring activities during all stages of the Project. Where recommendations referred to in the documents of the Register are not expressly referred to in this Permit, such recommendations are nevertheless to be implemented unless expressly excluded in this Permit or otherwise agreed by the Director.

Any variation of the submissions shall be approved by the Director in writing or as prescribed in the relevant permit conditions. Any non-compliance with the submissions may constitute a contravention of the EIAO (Cap. 499).

Electronic copies of all finalised submissions required under this Permit shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hard copies.

- The Permit Holder shall notify the Director in writing the commencement date of operation of the Project no later than 1 month prior to the commencement of operation of the Project. 2. <u>Specific Conditions</u> 特定條件

Employment of Environmental Team (ET) 聘用環境小組

- 2.1 An ET shall be established by the Permit Holder no later than two months before the commencement of construction of the Project. The ET shall not be in any way an associated body of the Contractor or the IEC for the Project. The ET shall be headed by an ET Leader. The ET Leader shall be a person who has at least 7 years of experience in environmental monitoring and auditing (EM&A) or environmental management. 許可證持有人須在工程項目建造工程展開前最少兩個月成立一個環境小組。環境小組不得與工程項目的承辦商或獨立環境查核人有任何關聯。環境小組須由一名環境小組組長帶領。該名環境小組組長須在環境監察及審核(「環監」)或環境管理方面至少有7年經驗。
- 2.2 The ET and the ET Leader shall be responsible for duties defined in this Permit and the EM&A Manual approved under Condition 3.1 of this Permit (hereinafter referred to as the EM&A Manual), including implementation of the EM&A programme in accordance with the EM&A requirements as contained in the EM&A Manual; and site inspections to audit the Contractor's site practice and work methodologies with respect to environmental mitigation measures recommended in the EM&A Manual and/or as required under this Permit and to take pro-active actions to pre-empt environmental problems.  - (ii) notifying the IEC within one working day of the occurrence of each and every instance or circumstance or change of circumstances, which may affect the compliance with this Permit and/or the recommendations in the EM&A Manual. Notification(s) shall be documented in the upcoming EM&A monthly report; and 在發生可能會影響本許可證及/或環監手冊的建議的合規情況的每宗事件、每種情況或每次情況變化後1個工作天內通知獨立環境查核人。通知須記錄於每月環監報告;以及
 - (iii) keeping a contemporaneous log-book of any such instance or circumstance or change of circumstances, which may affect the compliance with this Permit and/or the recommendations in the EM&A Manual. The format of the log-book shall be certified and approved by the IEC. The log-book shall be kept readily available for



inspection by all persons assisting in supervision of the implementation of this Permit and the recommendations in the EM&A Manual or by the Director or his authorized officers.

The IEC shall not be in any way an associated body of the Contractor or the ET for the Project. The IEC shall be a person who has at least 7 years of experience in EM&A or environmental management. 許可證持有人須在工程項目建造工程展開前最少兩個月聘用一名獨立環境查核人。獨立環境查核人不得與工程項目的承辦商或環境小組有任何關聯,而該名獨立環境查核人須在環監或環境管理方面至少有7年經驗。
- 2.5 The IEC shall be responsible for duties defined in the EM&A Manual and this Permit, including the following:

 - (i) auditing the overall EM&A performance, including the implementation of all environmental mitigation measures and monitoring activities on site, submissions required in the EM&A Manual, and/or under this Permit. - (iv) notifying the Director by fax or email, within one working day of receipt of notification from the ET Leader, or identification by the IEC and his team, of each and every change of circumstances or suspected and/or potential non-compliance with this Permit and the recommendations in the EM&A Manual, which might affect the monitoring or control of adverse environmental impacts arising from the Project. Notification by the Permit Holder is the same as notification by the IEC for the purpose of this Condition;

- 2.6 If the Director considers the IEC fails to discharge the duties of the IEC as defined in the EM&A Manual or in this Permit, the Director may require the Permit Holder by notice in writing to replace the IEC. Failure to replace the IEC as directed or further failure to so notify the Director despite employment of a new IEC may render this Permit liable to suspension, cancellation or variation.

The Permit Holder shall inform the Director no later than 2 weeks before the scheduled submission date of the EP submission in writing in case of any subsequent change(s) to the submitted EP Submission Schedule. 2.9 The Permit Holder shall, no later than 1 month before the commencement of construction of the Project or otherwise agreed by the Director, deposit with the Director 2 hard copies and 1 electronic copy of a Decking Arrangement Plan (DAP). The DAP shall include the detailed designs, phasing, location plans of appropriate scale, and layout of the decking arrangement during construction of the Project to



reduce construction dust and noise impacts from major excavation works areas. The DAP shall include an implementation schedule in table form to clearly list out the measures to be implemented, and the implementation party, location and timing for the implementation of the measures. If there are any change(s) to the decking arrangement set out in the deposited DAP, the Permit Holder shall, no later than 1 month before the implementation of such change(s), deposit with the Director 2 hard copies and 1 electronic copy of the updated DAP with clear indication of the proposed change(s). The Permit Holder shall, no later than 1 month before the commencement of 3.1 construction of the Project or otherwise agreed by the Director, submit 4 hard copies and 1 electronic copy of an EM&A Manual with reference to the EM&A Programme recommended in the Project Profile (Register No.: PP-655/2023) to the Director for The EM&A Manual shall contain updated versions of the EM&A Programme and the Implementation Schedule on pollution control/mitigation measures recommended in the Project Profile (Register No.: PP-655/2023). The EM&A Manual shall also incorporate the updated construction dust monitoring requirements as stipulated in the prevailing Technical Memorandum on Environmental Impact Assessment Process as at the submission of EM&A Manual. Any changes to the EM&A requirements or programme or termination of the programme shall be justified by the ET Leader and verified by the IEC as conforming to the information and requirements contained in the EM&A Manual before submission to the Director for approval.

- 3.4 The Permit Holder shall submit 1 hard copy and 1 electronic copy of Baseline Monitoring Reports to the Director at least 2 weeks before the commencement of construction of the Project. The submissions shall be certified by the ET Leader and verified by the IEC as having complied with the requirements as set out in the EM&A Manual before submission to the Director. Additional copies of the Baseline Monitoring Reports shall be provided upon request by the Director.

The monthly EM&A Reports shall include an executive summary of all environmental audit results, together with actions taken in the event of non-compliance (exceedances) of the environmental quality performance limits (Action and Limit Levels), complaints received and emergency events relating to violation of environmental legislation. The submissions shall be certified by the ET Leader and verified by the IEC as having complied with the requirements as set out in the EM&A Manual before submission to the Director. For the HTML version, a content page capable of providing hyperlink to each section and sub-section of these Reports shall be included in the beginning of the document. Hyperlinks to all figures, drawings and tables in these Reports shall be provided in the main text from where the respective references are made. All graphics in these Reports shall be in interlaced GIF, JPEG or PDF format unless otherwise agreed by the Director. The content of the electronic copies of these Reports must be the same as the hard copies.

All environmental monitoring data described in Condition 4.1 above shall be made available to the public via the abovementioned dedicated Internet website in the shortest possible time and in any event no later than 2 weeks after the relevant environmental monitoring data are collected or become available, unless otherwise agreed with the Director. All finalized submissions and plans shall be made available to the public via the dedicated Internet website in the shortest possible time and in any event no later than 2 weeks after the submissions and plans are approved by or deposited with the Director, unless otherwise agreed with the Director. 

 - (i) on a first conviction on indictment to a fine of \$2 million and to imprisonment for 6 months;

 - (ii) on a second or subsequent conviction on indictment to a fine of \$5 million and to imprisonment for 2 years;

 - (iii) on a first summary conviction to a fine at level 6 and to imprisonment for 6 months;
